# The Organisers of the Oxford Symposium on Employee Ownership

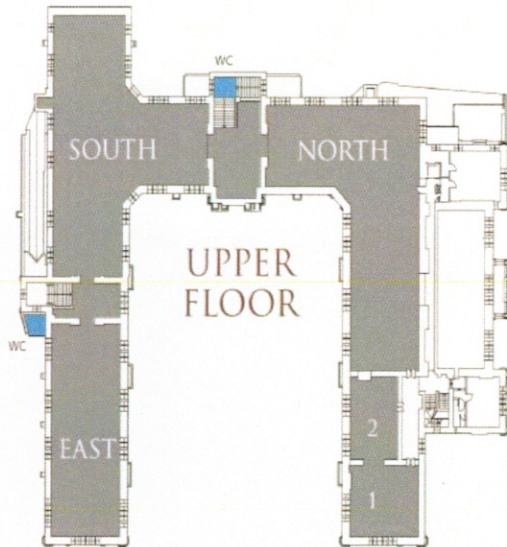

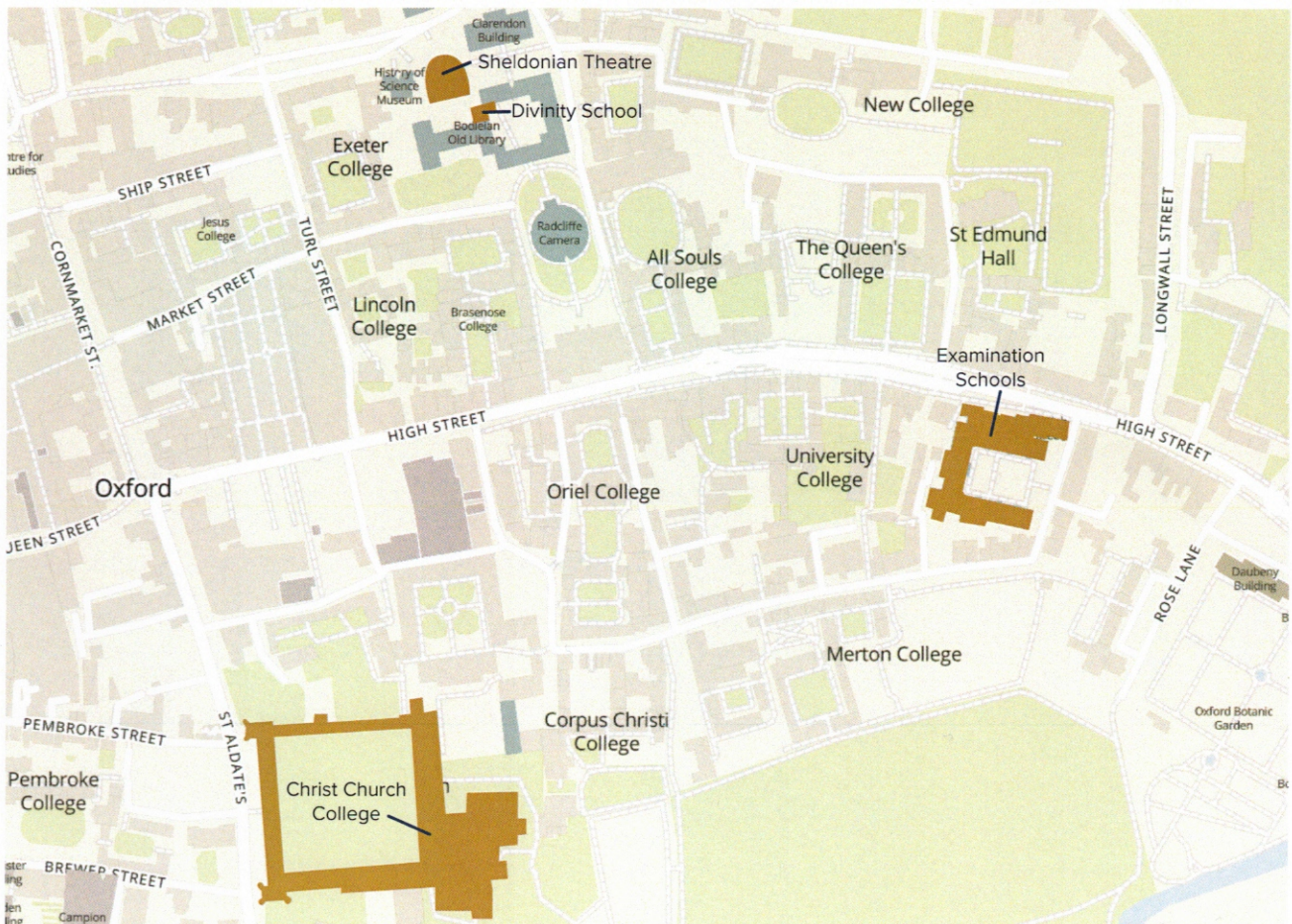
